RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

**RE: PUBLICATION OF PHOTOGRAPHIC, FILM OR ELECTRONIC IMAGES**

**KNOW ALL MEN BY THESE PRESENTS:** I hereby release from all liability and indemnity Tidewater Figure Skating Club and agree that figure skating related photographic, film or electronic images of my child may appear in TFSC publications or advertisements during the course of the United States Figure Skating Association's membership year, commencing with July 1 and ending with June 30. I do hereby release, acquit and forever discharge Tidewater Figure Skating Club, as well as their agents, employees, servants, successors, assigns, heirs, executors, administrators, Board of Directors and members from any and all actions, causes of action, claims, demands, costs, losses of service, expenses and compensation of any kind whatsoever, which now have or may hereafter have on account of or arising out of any emotional, psychological, or physical injury suffered as a result of another's use or misuse of said images for whatever purpose or reason. I further agree for myself, my heirs, executors, and administrators, to hold harmless those hereby released from and against all expenses incurred by any of them as a result of any claim or cause of action brought on my behalf or on behalf of any child of mine for anything from which I have released them as aforesaid or for any injury, or loss or event of any kind and every kind whatsoever. I agree to pay all recoveries, judgments, court costs, legal fees and expenses of and against those released hereby as a result of said claims or causes of action against those released hereby as a result of said claims or causes of action in defense of the same.

In making this release and agreement, it is understood and agreed that I rely wholly and solely on my own judgment regarding the dangers and risks involved, both known and unknown, and that I have not been influenced to any extent whatsoever in making this Release by any representations or statements with regard to safety or the legal liability for my child's safety or any injuries. I agree and understand that nothing contained herein shall be construed as an admission of liability on the part of those released hereby.

I further declare and represent that no promise or agreement not herein expressed has been made to me. This Release contains the entire agreement between those released hereby to the herein contained subject matter, and the terms of this Release are contractual and not merely a recital.
